#### Report on compliance and other matters

As part of obtaining reasonable assurance about whether the District's basic financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the financial statements. However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. 

Specifically, in order to more precisely identify grant program expenditures, the Department requests that grantees include on the Schedule of Expenditures of the Federal Awards (SEFA) page of Form SF-SAC, if applicable: (1) whether the program is novel coronavirus 2019 (COVID-19) relief assistance (see list below of COVID-19 programs); and (2) the subprogram ALN alpha.


Action Requested: On page 2 of the Form SF-SAC,<sup>3</sup> under "Part II: FEDERAL AWARDS" in the chart labeled "Schedule of Expenditures of Federal Awards" under column c with the heading "Additional Award Identification" include the phrase "COVID-19" if the program is considered COVID-19 assistance). Then place a comma (,) after COVID-19 and include the full ALN number and alpha character (A, B, C, etc.) (see Example 1 below).

OMB's instructions to auditees in the FY 2020 Compliance Supplement instructed auditees to include COVID-19 in Column c (see 2020 Compliance Supplement Appendix VII beginning on page 8-VII-2 at <a href="https://www.whitehouse.gov/wp-content/uploads/2020/08/2020-Compliance-Supplement\_FINAL\_08.06.20.pdf">https://www.whitehouse.gov/wp-content/uploads/2020/08/2020-Compliance-Supplement\_FINAL\_08.06.20.pdf</a>)
