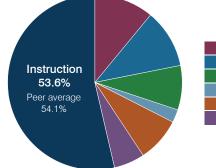

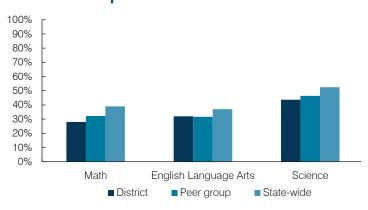

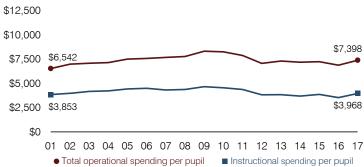

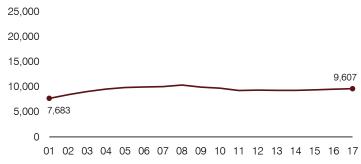
5-year spending trend (2012 through 2017)

Total operational spending per pupil, adjusted for inflation, increased by 5 percent. The percentage of dollars spent on instruction varied year to year, decreasing slightly overall from 54.2 to 53.6 percent. Overall, as a percentage of total operational spending, administration, plant operations, and food service increased slightly, while instruction support decreased and transportation decreased slightly.

Total operational and instructional spending per pupil (inflation adjusted to 2017 dollars)



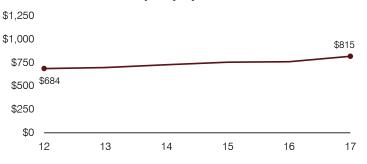

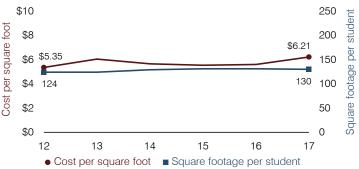

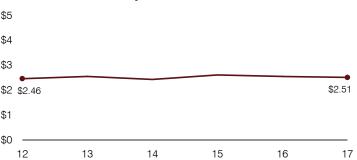
Administrative cost per pupil
